Standard message and data rates from your mobile carrier may apply to SMS communications. Carlson Financial is not responsible for any charges incurred by you through your mobile provider for sending or receiving text messages.

5. Opt-Out/Unsubscribe

You may opt out of receiving SMS messages at any time by replying with the word "STOP" to any text message you receive from Carlson Financial. Once we receive your request, we will stop sending you promotional or non-essential messages. Please note that you may still receive account-related notifications that are necessary to fulfill your services with Carlson Financial.
